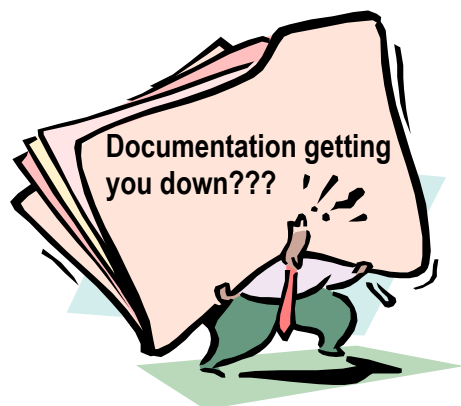


Alternate Assessment Training “Train the Trainer” 2010-2011



SST 13 is offering a train-the-trainer model for Alternate Assessment Training. Districts may register **up to 3 people**, to serve as trainers and support for Alternate Assessment within their district (see Sept. 28 NOTE below). Any updates on the progress of the *2% Modified Assessment* will also be addressed at the training.

Community schools and other agencies/organizations **may send one person** to a training. Trainers will then have responsibility to train others in their district or organization on the Alternate Assessment process and materials. SST 13 will provide one copy of training materials to each designee attending the training.

All District Test Coordinators and Building Test Coordinators are expected to have sufficient knowledge of Alternate Assessment to *provide support to individual teachers*. SST 13 will assist district trainers by identifying technical resources. **Peer-review** networking dates, offered in late January or early February, will be announced at trainings and are open to ALL teachers.
